## CAREER AND COLLEGE PROMISE (CCP) STUDENT/PARENT AGREEMENT

**Please initial each item, then sign and date at the bottom to confirm you are aware of these factors prior to enrolling in the CCP program at James Sprunt Community College.** Career & College Promise is a program that offers eligible high school students the opportunity to take college courses in a structured pathway that leads to a certificate, diploma, or degree as well as to provide training for entry-level jobs. As a college collaboration with your local high school, students and parents must understand the following:

Student	Parent	Statement
		The Career and College Promise (CCP) courses and program are regulated by the North Carolina Community College System and are taught by college instructors.
		Students must receive a C or better to earn college credit. Grades earned at James Sprunt Community College will be reflected on the student's high school transcript and will be used in calculating their high school GPA.
		Students who do not complete the mandatory Enrollment Activity and/or do not attend class by the 10% date of the course will be withdrawn from the class.
		Attendance in online courses is based on assignments submitted. Punctual attendance is expected. Students whose absences exceed the allowed number per the instructor syllabus may be withdrawn from the course by the instructor. Students that are dropped by the instructor will receive a W-withdrawal and may have negative implications on their high school and college transcripts.
		All grades earned at James Sprunt Community College will become part of the student's permanent college transcript and will follow them throughout their college career, including withdrawal grades.
		As a CCP student, I understand that I am taking college courses. I must abide by JSCC's academic and behavior policies. I authorize JSCC's staff to release information regarding my enrollment, academic progress, disciplinary matters, and/or attendance to my high school principal and high school counselor.
		Students who wish to drop or withdraw from a college course must have documented consent of their high school principal or their designee. Some local policies do not allow students to withdraw from a course.
		Because college courses are academically rigorous, students should be prepared to spend a minimum of 2-3 hours of study outside of class for each hour spent in class (# of credit hours) .
		Students are expected to read and review the syllabus for each class they are enrolled in. Each course syllabus will explain course assignments, requirements, grading and attendance policies.
		Students in college courses are always expected to conduct themselves with maturity and respect in compliance with the James Sprunt Community College Student Handbook.
		Students who have a concern about a course should first speak with their instructor. Students are welcome to consult with their high school counselor, CCP Liaison, or Career Coach in this process.
		Per FERPA (1974) Parents/Guardians are NOT allowed to contact their student's instructor. They are instead encouraged to empower their student to advocate for themselves or contact their CCP Liaison, Career Coach, or high school counselor. Parents must have a FERPA form on file with JSCC to discuss their child's courses.
		Students who have a diagnosed disability/504 Plan/IEP must self-identify to James Sprunt Community College. Any accommodations at the high school will not automatically follow them to JSCC. Students must self-disclose to Amber Ferrell, 910-275-6368, aferrell@jamesprunt.edu.
		To maintain eligibility, students must continue progressing toward high school graduation and must maintain at least a 2.0 GPA in their college classes (after 2 courses). Students that fall below a 2.0 will be on academic probation.
		Students may not take courses outside of their pathway until the pathway is completed or changed. All changes require rationales and approvals.
