

As an honorably discharged veteran, you are entitled to education benefits, and are eligible to participate in certain education programs. Veterans are accorded the same rights and must meet all academic requirements and maintain the same academic standards as any student attending James Sprunt Community College.

Active duty service members should consult with the Education Services Officer (ESO) on their military installation before submitting an application for VA benefits.

#### **BENEFITS AVAILABLE**

## **MONTGOMERY GI BILL® (Chapter 30)**

Eligibility for basic educational assistance can be established by individuals who first became members of the Armed Forces of first entered on active duty as a member of the Armed Forces after June 30, 1985 or is voluntary active duty.

## **VOCATIONAL REHABILITATION (CHAPTER 31)**

The purpose of this program is to provide eligible veterans with compensable service-connected disabilities all services ad assistance necessary to enable them to achieve maximum independence, to become employable, and to obtain and maintain suitable employment. Basic entitlement and necessity for training and rehabilitation are determined by the Department of Veterans Affairs. The Regional Office in Winston-Salem, NC, Vocational Rehabilitation Department notifies the veterans and the college regarding approval for training. Payment is made directly to the school for tuition & fees.

### POST - 9/11 GI BILL® (Chapter 33)

This program provides VA Educational Benefits to eligible veterans for services that were performed after September 10, 2001 and active duty. Members must have served at least 90 aggregate days on active duty. However, individuals honorably discharged for a service-connected disability who served 30 continuous days after September 10, 2001, may also establish eligibility. You may also transfer your Chapter 33 benefits to their children and/or spouse. This is called a transfer of entitlement. A transfer cannot exceed 36 months to all dependents. Payments are made directly to the school.

# SURVIVOR'S AND DEPENDENTS' EDUCATIONAL ASSISTANCE (CHAPTER 35)

This program assists dependents and the spouse of a veteran who died of a service-connected disability or who has a service-connected total permanent disability. The child or spouse of a person who is on active duty as a



member of the Armed Forces and who now is, and, for a period of 90 days, has been, listed by the Secretary as missing in action, captured in line of duty by a hostile force, or forcibly detained or interned in the line of duty by a foreign power should be eligible for these benefits.

## **MONTGOMERY GI BILL® – SELECTED RESERVE (CHAPTER 1606)**

This program provides up to 36 months of education benefits to members of the Selected Reserve. This includes the Army, Navy, Air Force, Marine Corps, and Coast Guard Reserves, as well as the Army National Guard and the Air National Guard. Reservist must have signed a six-year obligation to serve in the Selected Reserve after 6/30/1985, completed your Initial Active Duty for Training (IADT), have your High School Diploma or GED before you completed your IADT, and in good standing in a drilling Selected Reserve unit. Benefits generally end 14 years from the date you become eligible or when you leave the Selected Reserves.

## **VETERANS RETRAINING ASSISTANCE PROGRAM (VRAP)**

This program provides eligible veterans with education benefits for up to 12 months of training. VRAP will provide training for programs of education that lead to a high demand occupation, as determined by the Department of Labor.

### NORTH CAROLINA NATIONAL GUARD TUITION ASSISTANCE PROGRAM

Active North Carolina National Guard members who have completed at least one year of satisfactory service in the North Carolina National Guard, and have a minimum of two years remaining as a member of the National Guard from the end of the academic period for which tuition assistance is requested may be eligible for tuition assistance. ### On-Line

## Paper Application

- Download and complete VA Form 28-8832 "Educational/Vocational Counseling Application"
- Mail or drop off the application to your local regional benefit office.

Full-time training for undergraduate students is 12 credit hours minimum at main campus or 6 credit hours minimum each term under accelerated terms. A student who enrolls for less than full-time will have the amount he/she can receive in benefits prorated each month according to how many days of classes are in each individual month. ### WHAT HAPPENS AFTER I APPLY?

Be advised that failure to provide the School's Veteran's Affairs (VA) Office with all required forms and a class schedule in a timely manner may result in a delay of benefits. A list of required documentation is listed below\*.

### **VETERAN'S AFFAIRS CHECKLIST\***

The following documents are required for **ALL** Educational Benefits. Additional documents required are listed under the specific chapters.

- Official transcripts (H.S. and <u>ALL</u> other institutions attended since high school) are to be turned into admissions
- Completion of a JSCC Application for Admission
- Signed & dated VA Procedures Manual
- Copy of VA Awards letter or Certificate of Eligibility (COE) or Statement of Benefits from va.gov.

- VA Form 22-1990 or 1990E Application (New) OR 22-1995 (Change of place or program)

After collecting the required documents, you will need to read and familiarize yourself with the procedures manual located on the Veteran Affairs page on the JSCC website. Please print the VA Procedures page and submit a signed copy along with all other required documents to the JSCC Financial Aid/VA office.

### **ONCE YOU ARE CERTIFIED:**

- Included in your award letter from VA will be information on verification of attendance. Some VA students are required to verify attendance monthly. For those students, we recommend you sign up for the monthly automatic email reminder through the W.A.V.E website (<a href="www.gibill.va.gov/wave/index.do">www.gibill.va.gov/wave/index.do</a>).
- For Post-9/11 (Chapter 33 students) the book allowance can come at any time during the month. Other payments are always paid at the end of the month.

To Keep Your Benefits Running Smoothly:

- You **MUST** provide the SCO with a copy of your schedule before re-certification for the next semester. Otherwise, YOU WILL NOT BE CERTIFIED.
- Keep in mind that VA will only pay for courses that are required for graduation as defined by your curriculum and as published in the catalog/bulletin. VA will not pay for non-degree or additional courses.
- In the event you wish to change your schedule, major, course(s), address, etc., you **must** inform the SCO of these changes.
